The defendant was the driver of a 2004 Lamborghini, which was traveling north on Crandon Boulevard, at a high rate of speed. In the 4000 Block, he lost control of the vehicle and skidded off the roadway, striking a tree. The passenger in the vehicle was killed on impact. Key Biscayne Fire Rescue responded to the scene and rendered first aid, at which time a strong odor of alcoholic beverage was smelled on the defendant's breath. The defendant was transported to Jackson Memorial Hospital Ryder Trauma Center, where medical personnel also smelled the presence of alcoholic beverage on his breath.

The defendant was placed under arrest at Jackson Memorial Hospital.

The defendant was a foreign national. Request surrender of immigration papers.
